For GPS use: 6127 PA Route 873, Slatington PA

Rt. 309 North from Rt.22 in Allentown PA

Take 309 North past LCCC and through Schnecksville.
Rt. 873 will branch off to the right at the Wachovia Bank - follow it!
At Neffs Church the road bends.
Great Companions is 1.1 miles on the right.
See 15th St. directions for more details.

15th St Exit from Rt.22

Exit North onto 15th St./Mauch Chunk Road for about 6 miles.
At the "T" junction in Ballietsville turn left on Rt. 329 West
After another mile, just after the crest of a hill, Rt. 329 will turn left again on Bellview Road
-- there is no stop at this intersection and this turn is easy to miss!
Soon after going through an underpass (the PA Turnpike) you'll come to Rt. 873.
You'll see the giant and beautiful Neffs Church. Go straight after the stop and you'll be on Rt. 873 North.
Great Companions is 1.1 miles on Rt. 873 on the right hand side.
Just after you pass through the town of Neffs you'll see a sign for Glencrest (don't turn).
There's a guardrail on your right, put on your right turn signal and slow down (even if there is a car directly behind you). There is a large "Great Companions" sign on the barn.
We have 2 driveways; we prefer you take the first which is before the barn.
If you miss it take the second drive which is just past the house and follow it around to the barn.

MacArthur Road / Rt 145 from Rt.22

Take 145 to the intersection with 329, turn left.
Go past Egypt and Ballietsville
Follow 15th St. directions

Awards

Qualifying ribbons will be awarded to each dog/owner team who achieves a score of 170 or better. Placement rosettes will be awarded to the top 5 high scoring teams in both A and B Classes. Championship rosettes will be awarded to all teams completing a Championship title.

General Information

Entries will not be accepted without an APDT Rally registration number. To obtain a registration number, please obtain a registration form from the APDT Rally website and mail directly to APDT Rally. Registration numbers must be obtained BEFORE entering this trial!

- This is an outdoor trial with Astroturf surface. Ample crating space. Please bring your EZ Ups for shade.
- Please bring your own food and water for yourself and for your dogs, as there will be limited food available.
- There will be no refunds for absent entries. Refunds will be made for withdrawn entries only if request is made prior to closing date and can be filled by the waiting list. Refunds will be made if the trials must be cancelled by the host organization due to severe weather. Refunds will be made for bitches in season if request is accompanied by a note from the exhibitor's veterinarian
- Please make checks payable to **Great Companions**.
- **No prong or choke collars will be allowed on show grounds.**
- **Move ups:** Closing date for Move ups is May 7.

Notice to Competitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of APDT Rally Obedience rules and regulations including but not limited to the following rules regarding entry:

- ◆ This trial is open to all dogs being at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- ◆ All dogs must be registered with APDT Rally to compete. Forms are available at www.apdt.com.
- ◆ Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.
- ◆ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- ◆ The organizing committee may refuse any entry for any reason.

In addition,

- ◆ THERE SHALL BE NO REFUND for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- ◆ Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check where notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse by owner/handler.
- ◆ No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.
- ◆ All dogs shall be shown in a flat buckle or snap collar, plain harness, or properly fitted martingale (limited slip) collar. No choke collar, prong collars, shock collars, no-pull harnesses, martingale leads, or head collars are allowed.
- ◆ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. All video, broadcast, and telecast rights for this event are the exclusive property of the APDT or the trial host(s).
- ◆ Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- ◆ Upon successful completion of an exercise, the owner may choose to briefly pet or touch the dog as a reward. The owner may also choose to give the dog food as a reward. Food may NOT be used as a lure to help the dog complete an exercise. Food rewards must be contained in pockets or hidden treat pouches and only be present in the owner's hand in between exercises. Any petting, touching, or feeding that significantly interrupts the flow of performance shall be scored accordingly.
- ◆ Dogs must remain under control at all times whether on or off leash while on show grounds. Day kenneling only is permitted, unless otherwise posted at the show site. Please pick up after your dog and yourself.
- ◆ APDT's official Rally-O Rules and Regulations are hereby incorporated by reference, a copy of which may be obtained by going to APDT.com/RallyO/index.htm.
